WS Transportation Coalition Meeting Minutes, Thursday, October 22, 2015 Neighborhood House Highpoint Center, 6400 Sylvan Way SW, Seattle, WA 98126

6:30-6:55 Co-chair Amanda Kay Helmick called the meeting to order, initiated introductions (see Attendees list below), starting w/WSTC board, peninsula guests, and Sound Transit (ST) presenters – Val Batey & Karen Kitsis. Then Ms. Helmick asked for news reports from board members:

- Action Comm. is capturing info for connecting with other organizations, so WSTC is represented w/neighborhood and other allied organizations
- Marty will do next meeting w/ Port to follow up on WSTC questions & concerns raised re: ingress-egress as T5 expansion and EIS progress
- Michael TJ Sound Trans Board meeting 10/22 "additive" to generate official list of projects in ST3 ballot proposal. If WSTC wants projects added to the list & studied by staff, we must lobby for them, & get input from our constituents about ST3 routing. ST staff has done preliminary cost & route guesses, presented to WSTC last winter. Generally, WSTC wants elevated or separated rail in WS, not at-grade mixing with and slowed down by traffic
- When we make comments, must come from specific source on website, or from one or both co-chairs (Amanda & Tom), w/ consistent message.
- Metro announced 20-40 new or enhanced routes, outside city. Current funding for enhanced services route must be 80% in city for funding, or w/inter gov't agreement, which is how 120 enhanced

7:00 ST guests introduced – they distributed hard copies of SOUND TRANSIT 3: CANDIDATE PROJECTS LIST, also available online at: http://www.soundtransit.org/sites/default/files/Motion%20M2015-80_0.pdf

WSTC envisions a fully-connected city, not piecemeal lines. One "ST Complete" issue is longer term use of taxing authority, which offers more options, better build-out of lines than current extent, and longer duration – 25-30 vs. 15 years, but makes process more efficient. ST3 vision is only run to WS Junction. ST Complete gets to 16th in White Center, & perhaps beyond.

Issue: ST's 15-year construction plan, devised during recession, just got minimum Ballard-WS Junction routing. WSTC wants more than just 2 stops into WS. Conventional ST wisdom is route just along Everett-Renton-Tacoma spine. But ST got solid funding authority from legislature, so let's do what DC & other cities do – plan a complete system, & just keep building; plan junctions instead of retrofits.

WSTC preferred option: bridge over Duwamish S of high bridge, station at Delridge, tunnel uphill through golf course to 35th station, then to Alaska Junction, turn south to Morgan or High Point, then south to Westwood, White Center, Burien, SeaTac.

Batey & Kitnis: elevated or underground @Duwamish -- \$6-8 billion, and B4 ST option—2 lines, \$4B-\$9B. Delridge stop needed; & because WS undulates, some sections would go underground, some elevated. Underground along public right of way.

Bridge options include costs for building. Bogue Plan 1912 routes same as 1968 Forward Thrust. This could have been finished by 1985 w/90% federal funding.

Discussion continued, covering political leader boldness & lack thereof, need for voter surveys, danger of putting both ST3 & ST4 on ballot, high levels of community engagement

across the city – some weeks, only Seahawks get more online traffic. ST studying how big it can go, & if it's got a sound financial plan, & if not, must extend ST3 period & cut plans back. Larger employers reluctant to engage until they know how routing & financing will look.

Challenge is to mix outright payment & plus bonding, do 25-30 construction years, so we can continue adding & never have to go back to Olympia. Funds cover maintenance & capital, and when initial work done, and ST has paid off cap expenditures, they can reduce taxes to cover operations & maintenance, and as bonds are paid off, and no more projects in pipeline, reduce taxes. If federal dollars available, help speed projx.
